## National Bank increases the dividend on its common shares

**Montreal, December 2, 2015 –** National Bank of Canada's (TSX: NA) Board of Directors announces today an increase of the dividend on its common shares from \$0.52 to \$0.54 per common share for the quarter ending January 31, 2016. This dividend will be payable on February 1<sup>st</sup>, 2016 to holders of record of common shares on December 21, 2015.

The Board of Directors also declares quarterly dividends on the following series of first preferred shares. These dividends are payable on February 15, 2016 to holders of record of first preferred shares on January 4, 2016.
