This 1<sup>st</sup> prospectus supplement (the “**1<sup>st</sup> Supplement**”) is supplemental to, forms part of and must be read in conjunction with, the base prospectus dated 15 June 2023 (the “**Prospectus**”) prepared by National Bank of Canada (the “**Issuer**” or the “**Bank**”) with respect to its U.S.\$12,000,000,000 Euro Note Programme. Capitalised terms used but not otherwise defined in this 1<sup>st</sup> Supplement shall have the meanings ascribed thereto in the Prospectus.

Application has been made to the Luxembourg *Commission de Surveillance du Secteur Financier* (the “**CSSF**”), in its capacity as competent authority under Regulation (EU) 2017/1129 (the “**Prospectus Regulation**”) to approve this 1<sup>st</sup> Supplement for use in connection with the issue of Notes (other than Exempt Notes) under the Programme. Application has also been made to the Luxembourg Stock Exchange under the Luxembourg law dated 16 July 2019 on prospectuses for securities, as amended or supplemented (the “**Prospectus Law**”), to approve this 1<sup>st</sup> Supplement for use in connection with (i) the issue of money market instruments which have a maturity of less than twelve months to be admitted to the Regulated Market under the Programme pursuant to Part III of the Prospectus Law, and (ii) Exempt Notes under the Programme pursuant to Part IV of the Prospectus Law.

The Issuer accepts responsibility for the information contained in this 1<sup>st</sup> Supplement. To the best of the knowledge of the Issuer the information contained in this 1<sup>st</sup> Supplement is in accordance with the facts and contains no omission likely to affect the import of such information.

This 1<sup>st</sup> Supplement has been prepared pursuant to Article 23(1) of the Prospectus Regulation and Article 52 of the Prospectus Law. The following information has been filed with the CSSF and the Luxembourg Stock Exchange, and is incorporated by reference into this 1<sup>st</sup> Supplement: the Bank’s Third Quarter Report to Shareholders for the quarter ended 31 July 2023 which includes the unaudited interim consolidated financial statements for the quarters ended 31 July 2022 and 31 July 2023 (the “**2023 Third Quarter Report**”). In addition, this 1<sup>st</sup> Supplement includes (i) an update to the section of the Prospectus entitled “**NATIONAL BANK OF CANADA – DIRECTORS AND SENIOR OFFICERS OF THE BANK**” as a result of a change to the Principal Occupation of a Director of the Bank and (ii) a new statement in respect of no significant change and no material adverse change.

there has been no material adverse change in the prospects of the Bank and its subsidiaries taken as a whole since 31 October 2022, being the date of the latest annual audited published consolidated financial statements of the Bank.”
