

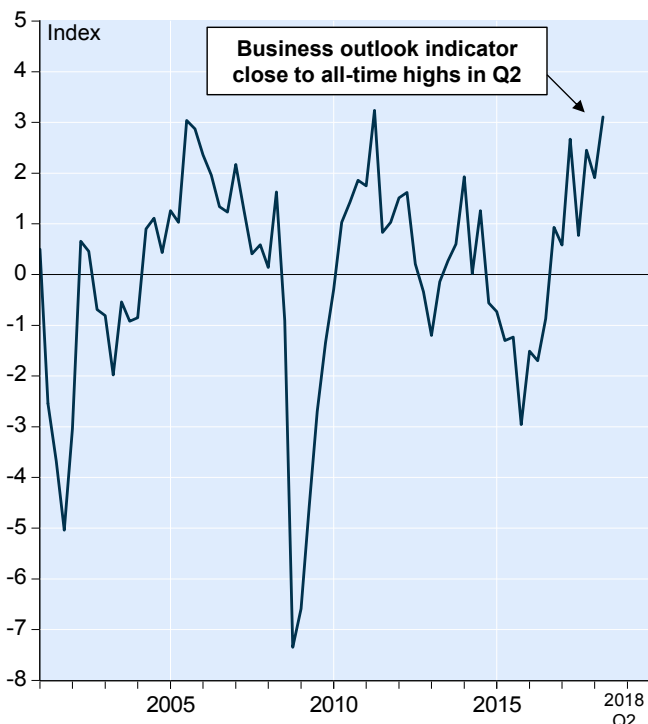
Canada Watch

Firms were generally upbeat about the economy in May and early June. At least that's the message from the latest Business Outlook Survey (conducted by the Bank of Canada between May 3rd and June 5th) whose aggregate indicator rose near an all-time high in Q2. Firms reported better sales growth in the last 12 months and expected it to remain positive over the next year. Capacity pressures became more intense with 57% of respondents (the highest since 2007) stating either some or significant difficulties in meeting an unexpected increase in demand. The proportion of respondents facing labour shortages increased to a decade-high of 34%, with the problem being particularly acute in BC, Ontario and Quebec. Firms were keen to increase employment, although less so to invest. As today's *Hot Charts* show, the balance of opinion on investment moved down, contrasting with hiring intentions. According to the central bank, higher investment plans were more prevalent in the services sector and concentrated among firms seeing capacity pressures and a strong sales outlook. So all is good right? Not so fast. As the BoC cautions in the report, "almost all interviews were conducted before the announcement of tariffs on steel and aluminum imports from Canada by the US". Business optimism likely took a subsequent dive, especially after the disastrous G7 meeting of June 8th/9th when Canada-U.S. trade relations took a turn for the worse.

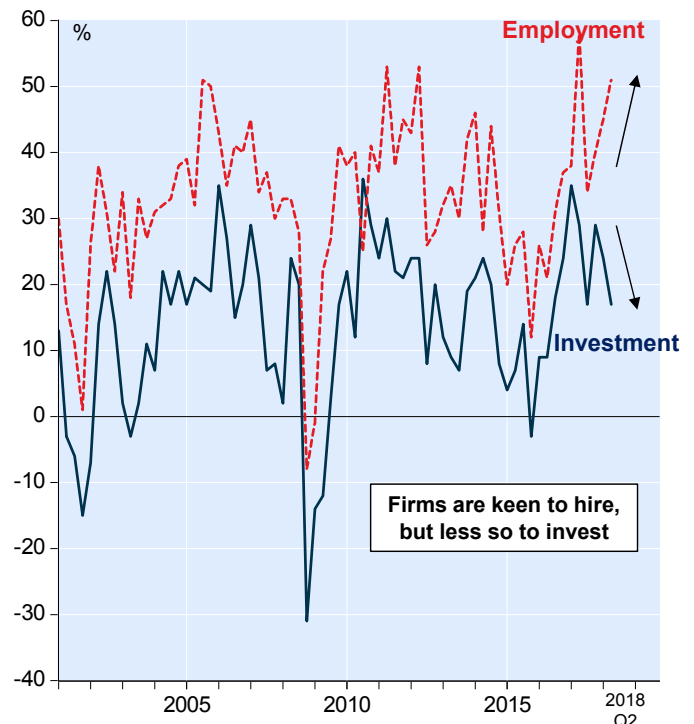
