Thursday, January 1 New Year's Day 2026 Friday, January 2 Day after New Year's Day	Files with due dates ranging from Thursday, January 1 <sup>st</sup> , 2026, to Monday, January 5 <sup>th</sup> , 2026, must be submitted by Wednesday, December 31 <sup>st</sup> , 2025, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Monday, February 16 Family Day / Louis Riel Day	No changes to cut-off times; files will be processed as usual.
<b>Friday, April 3</b> Good Friday	Files with due dates ranging from Friday, April 3 <sup>rd</sup> , to Monday, April 6 <sup>th</sup> , must be submitted by Thursday, April 2 <sup>nd</sup> , 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
<b>Monday, May 18</b> Victoria Day	Files with due dates ranging from Saturday, May 16 <sup>th</sup> , to Tuesday, May 19 <sup>th</sup> , must be submitted by Friday, May 15 <sup>th</sup> , 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Wednesday, June 24 Saint-Jean-Baptiste Day	No changes to cut-off times; files will be processed as usual.
<b>Wednesday, July 1</b> Canada Day	Files with due dates ranging from Wednesday, July 1st, to Thursday, July 2nd, must be submitted by Tuesday, June 30th, 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Monday, August 3 Civic Holiday	No changes to cut-off times; files will be processed as usual.
<b>Monday, September 7</b> Labour Day	Files with due dates ranging from Saturday, September 5 <sup>th</sup> , to Tuesday, September 8 <sup>th</sup> , must be submitted by Friday, September 4 <sup>th</sup> , 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Wednesday, September 30 National Day for Truth and Reconciliation	Files with due dates ranging from Wednesday, September 30 <sup>th</sup> , to Thursday, October 1 <sup>st</sup> , must be submitted by Tuesday, September 29 <sup>th</sup> , 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Monday, October 12 Thanksgiving	Files with due dates ranging from Saturday, October 10 <sup>th</sup> , to Tuesday, October 13 <sup>th</sup> must be submitted by Friday, October 9 <sup>th</sup> , 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Wednesday, November 11 Remembrance Day	Files with due dates ranging from Wednesday, November 11 <sup>th</sup> , to Thursday, November 12 <sup>th</sup> , must be submitted by Tuesday, November 10 <sup>th</sup> , 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Friday, December 25 Christmas Day Monday, December 28 Boxing Day	Files with due dates ranging from Friday, December 25 <sup>th</sup> , to Tuesday, December 29 <sup>th</sup> , must be submitted by Thursday, December 24 <sup>th</sup> , 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.
Friday, January 1 New Year's Day 2027 Monday, January 4 Day after New Year's Day	Files with due dates ranging from Friday, January 1st, 2027, to Tuesday, January 5th, 2027, must be submitted by Thursday, December 31st, 2026, prior to 3:00 p.m. ET / 1:00 p.m. MT.

## Pre-authorized debits (PAD)

Pre-authorized debit transactions cannot be processed during a weekend or a bank holiday in Canada and will be debited from the payer's account on the next business day. The file transfer dates mentioned above also apply to the PADs.
