## 1. The contest

National Bank of Canada is the contest organizer for the NBC Platinum X Piknic Électronik 2026 contest. The contest runs from Tuesday, June 30, to Friday, July 31, 2026.

## 2. Who can participate?

You can participate in the contest if:

- you are a resident of Canada, and
- you have reached the age of majority in your province or territory.

This contest is not open to employees, mandataries or representatives of the contest organizer or its subsidiaries, advertising and promotion agencies, suppliers of prizes, materials and services related to this contest, members of their respective immediate family (siblings, children, parents), common-law or legal spouses or any persons residing with these employees, mandataries or representatives.

## 3. How to enter

You can enter the contest during the Contest Period in either of the following ways:

- 3.1** Apply for a National Bank Platinum Mastercard™ credit card (as the primary cardholder) via [nbc.ca](https://nbc.ca) or through an advisor between Tuesday, June 30, and Friday, July 31, 2026 and activate the card between June 30, and August 16, 2026.

### **Additional entry:**

Make a purchase transaction using your digital wallet (e-wallet) with your National Bank Platinum Mastercard credit card.

Subject to your compliance with these contest rules, we will use the personal information provided to us (first and last name, telephone number [including area code], complete address [including postal code] and your email address). This information will be entered in the database used for the contest in order to grant you a contest entry. You will obtain one entry in the contest.

### **3.2** No purchase necessary

You may enter the contest applying for a National Bank Platinum Mastercard credit card (as the primary cardholder) via [nbc.ca](https://nbc.ca) or having received the contest email, or completing the associated form.

To participate in this way, you must:

1. Send us an original handwritten letter of at least 50 words explaining why you would like to win one (1) pair of VIP tickets to the **Piknic Électronik event on Sunday, September 13, 2026, in Montreal**, with an approximate value of **\$100**.

Upon receipt of your letter containing all required information, we will enter the personal information provided (first and last name, telephone number [including area code], address [including postal code] and email address) in the database used for this contest. You will receive one entry in the contest.

Write-in entries are subject to the same eligibility criteria applicable to other entries.



## 4. Contest participation limits

There is a limit of one (1) per person during the Contest Period, regardless of the manner of participation.

### Additional entry:

Make a purchase transaction using your digital wallet (e-wallet) with your National Bank Platinum Mastercard credit card.

Subject to your compliance with these rules, we will use the personal information provided (last name, first name, phone number including area code, mailing address including postal code, and email address).

## 5. Prize

A total of 50 pairs of VIP tickets are offered as part of the contest. Each prize consists of one (1) pair of VIP tickets to the **Piknic Électronik event on Sunday, September 13, 2026, in Montreal**, with an approximate value of **\$100**.

The prize is non-transferable and not redeemable for cash, and must be accepted as awarded.

No compensation or reimbursement will be provided for transportation, accommodation or any other expenses incurred to claim the prize, which are entirely the responsibility of the winner.

## 6. Draw

The draw will take place on August 20, 2026, at 12:00 p.m., at our offices located at 800 Saint-Jacques Street, 28th floor, Montreal, QC H3C 1A3.

Fifty (50) eligible entries will then be randomly selected. The draw will be conducted from all eligible entries received and recorded during the contest period in order to award the 50 prizes.

## 7. Odds of winning

## 8. Conditions for participants selected

- 8.1** In order to be declared a winner if your contest entry is selected, you must:
- be able to be contacted by email within five (5) days of the draw;
  - correctly answer, without assistance and within a limited time, a mathematical skill-testing question. We will ask you this question over the telephone at a time agreed upon in advance; and
  - complete and return the declaration and liability waiver within five (5) days of receiving it from us.
- 8.2** By signing the declaration, you agree to the following:
1. The prize will be as it is described in these contest rules.
  2. You cannot transfer the prize to another person, exchange it for money or replace it with another prize.
  3. Once your prize has been confirmed, the performance of the services related to the prize will become the sole and complete responsibility of the various suppliers for the prize.
  4. We have permission to use your full name, photograph, statements about the prize, geographical location and/or voice for publicity purposes. You will not be compensated for the use of any of these.
  5. We are not liable for any damage you may incur as a result of the acceptance or use of your prize, in particular any tax impact. You also release our subsidiaries, advertising and promotional agencies, suppliers of materials, prizes and services related to this contest as well as their employees, agents and representatives from any liability.
- 8.3** Within 10 days of receiving your declaration form, we will contact you again with information about how you will receive your prize.
- 8.4** If you do not meet these conditions, or any other conditions outlined in the contest rules, you will be disqualified. If time permits, we may select another entry at random until a winner is declared. Unclaimed prizes may be withdrawn.

## 9. Conditions for all participants

- 9.1** All of our decisions regarding this contest are final and without appeal.
- 9.2** You also release our subsidiaries, advertising and promotional agencies, suppliers of materials, prizes and services related to this contest as well as our employees, agents and representatives from any liability related to:
1. your participation or attempted participation in the contest;
  2. damage caused by downloading a webpage or software or transmission of information for the purposes of participating in the contest; and
  3. an inability or limited ability to participate due to a malfunction of any computer hardware, software or communication line resulting in the loss or absence of a network communication, or any faulty, incomplete, incomprehensible or deleted transmission by a computer or network.
- 9.3** We in no way guarantee that the contest website will be available or functional without interruption during the entire contest period or that it will be free of error.
- 9.4.** During the contest period, our computer system may not be able to register all entries submitted. The winner will be selected from entries that were registered only. Participation in the contest may be ended in whole or in part prior to the date set out in these contest rules. In this case, a winner be selected from the entries received and registered prior to the event that ended participation in the contest.
- 9.5** The entry form, write-in entries and waivers are our property and will under no circumstances be returned.
- 9.6** We will not contact you about the contest except as described in the contest rules or at our discretion.
- 9.7** Your personal information will be used for the purposes of the contest. By entering the contest, you agree to the use of your personal information at the time you enter the contest or receive a prize.

## 10. Our recourse

- 10.1** We may verify your entry form, write-in entries and waivers. We may reject the entry form, write-in entries and waivers if they are incomplete, fraudulent, late, etc. The entry form, write-in entries and waivers that are rejected do not qualify, depending on the case, as an entry or for a prize.
- 10.2** We reserve the right to disqualify or cancel any of your entries if you participate or attempt to participate in a manner contrary to these contest rules or that is unfair to the other participants (e.g., hacking, submitting more entries than the permitted number). You may be referred to the competent legal authorities.
- 10.3** Any attempt to deliberately sabotage any website related to the contest or to hamper the legitimate conduct of the contest is a violation of civil and criminal law. In the event of such an attempt, we reserve the right to reject your entry and seek recourse under the law.
- 10.4** We reserve the right at all times, at our sole discretion, to cancel, terminate, modify or suspend this contest, in whole or in part, if any event or human intervention occurs that could corrupt or affect the administration, security, impartiality or conduct of the contest. Under no circumstances will we be required to award more prizes than provided or to award prizes otherwise than in accordance with these rules.

## 11. Interpretation of the contest rules

- 11.1** The participant is defined by these rules as the person identified on the entry form or write-in entry. The prize will be remitted to that person if they are selected and declared the winner.
- 11.2** Should any clause of these rules be declared unenforceable or invalid by a court of competent jurisdiction, said clause will be considered invalid; however, all other clauses that are not affected will be applied.
- 11.3** In the case of discrepancies between the English and French versions of the contest rules, the French version will be considered correct.
