The table below is a practical tool that will help you determine how much you can donate.

## Tax advantages of a cash donation

The table below illustrates the approximate amount of the real cost of a cash donation when considering the non-refundable tax credit<sup>1</sup>:

**Please note:** The charitable donation tax credit is a non-refundable tax credit that applies for a given year and reduces the tax bill of that year. In other words, a non-refundable tax credit has no value if the donor has no tax to pay. However, the donations can be claimed in the year the donation is made or during **the following 5 years**.
