Management Discussion of Fund Performance

Results of Operations

For the six-month period ended June 30, 2024, the NBI Unconstrained Fixed Income Fund's Investor Series units returned -0.77% compared to -0.20% for the Fund's benchmark, the Bloomberg Global Aggregate Index (CAD Hedged). Unlike the benchmark, the Fund's performance is calculated after fees and expenses. Please see the *Past Performance* section for the returns of all of the Fund's series, which may vary mainly because of fees and expenses.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the manager. This rate may change from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

The Fund's net asset value rose by 4.26% over the period, from \$2.387 billion as at December 31, 2023 to \$2.488 billion as at June 30, 2024.

In the first half of 2024, the global economic landscape experienced a series of nuanced shifts, marked by fluctuating inflation rates, evolving monetary policies, and varied performance across different market sectors.

The labour market showed resilience, with nonfarm payrolls surpassing estimates and wage growth maintaining a steady moderation above 4%. As the year progressed, US inflation continued its upward momentum initially, driven by shelter and auto insurance costs, leading to a temporary rise in the 10-year US Treasury yield to 4.67% in April.

Overall, the first half of 2024 was characterized by a complex interplay of inflationary pressures, cautious monetary policies, and varied market performances, setting a nuanced stage for the remainder of the year.

In this context, the Fund underperformed its benchmark for the period. The Fund benefited from its exposure to high yield and investment grade credit. High yield contributed as US and European bonds benefited from a positive spread tightening move in the first quarter, based on resilient corporate profitability and easier financial conditions, with support from a strong carry profile in the second quarter.

Emerging market debt detracted from returns. The Fund's FX positioning was the largest detractor over the period. The Fund's duration positioning marginally detracted, mainly driven by the Fund's short US Treasury position as rates fell over the latter part of the second quarter.

Recent Developments

Over the period, the Fund increased headline duration from 3.5 to 4.3 years. The Fund increased its exposure to securitized products from 9% to 15%, primarily by adding agency mortgage-backed securities given attractive valuations. The Fund reduced its high yield exposure from 23% to 14% while marginally decreasing its investment grade credit exposure from 36% to 35%. Additionally, the Fund marginally increased its overall emerging market debt exposure from 15% to 16%.

The soft landing is set to continue as the economy glides towards trend growth and 2% inflation. The portfolio manager expects that further evidence of gradual moderation in the labour market over the coming months can enable the US Federal Reserve to cut rates in September and ease the monetary policy pressure on households and businesses.

According to the portfolio manager, the conditions are in place to sustain the soft landing and investors should target opportunities to add high quality carry to portfolios, in anticipation of interest rate cuts later this year. The portfolio manager favours corporate credit with considerable money on the sidelines that should flood into the market and drive spreads narrower as well as securitized credit, and there are selective opportunities in local currency emerging markets sovereign debt.

Related Party Transactions

National Bank of Canada ("the Bank") and its affiliated companies' roles and responsibilities related to the Fund are as follows:

Trustee, Custodian, and Registrar

Natcan Trust Company ("NTC"), a direct or indirect wholly-owned subsidiary of the Bank, is the Fund's trustee. In this capacity, it is the legal owner of the Fund's investments.

NTC acts as registrar for the Fund's securities and the names of securityholders. NTC also acts as the Fund's custodian. The fees for NTC's custodial services are based on the standard rates in effect at NTC.

Agent for securities lending transactions

NTC acts as the agent for securities lending transactions acts on behalf of the Fund in administering securities lending transactions entered into by the Fund. NTC is an affiliate of the Manager.

Fund Manager

The Fund is managed by National Bank Investments Inc. ("NBII"), which is a wholly-owned subsidiary of the Bank. Therefore, NBII provides or ensures the provision of all general management and administrative services required by the Fund's current operations, including investment consulting, the arrangement of brokerage contracts for the purchase and sale of the investment portfolio, bookkeeping and other administrative services required by the Fund.

The Manager pays the operating expenses of the Fund other than its "Fund costs" (defined below) (the "variable operating expenses"), in exchange for the Fund's payment to the Manager of annual fixed-rate administration fees with respect to each series of the Fund.

The administration fees are equal to a specified percentage of the net asset value of each series of the Fund, calculated and paid in the same manner as the Fund's management fees. The variable operating expenses payable by the Manager include, but are not limited to: transfer agency and recordkeeping costs; custodial costs; accounting and valuation fees; audit fees and legal fees; costs of preparing and distributing financial reports, simplified prospectuses, annual information forms, Fund Facts, continuous disclosure material and other securityholder communications; and costs of trustee services relating to registered tax plans, as applicable.

In addition to administration fees, the Fund shall also pay certain Fund costs, namely: taxes (including, but not limited to, GST/HST and income taxes); costs of compliance with any changes to existing governmental or regulatory requirements introduced after August 1, 2013; costs of compliance with any new governmental or regulatory requirements, including any new fees introduced after August 1, 2013; interest and borrowing costs; costs related to external services that were not commonly charged in the Canadian mutual fund industry as at August 1, 2013; Independent Review Committee costs, including compensation paid to IRC members, travel expenses, insurance premiums and costs associated with their continuing education; and variable operating expenses incurred outside of the normal course of business of the Fund.

The Manager may, from time to time and at its sole discretion, decide to absorb a portion of a series' management fees, administration fees or Fund costs.

As described under the heading *Management Fees*, the Fund pays annual management fees to NBII as consideration for its services.

Portfolio Manager

The Manager has appointed National Bank Trust Inc. ("NBT"), an indirect wholly-owned subsidiary of the Bank, as the portfolio manager for the Fund. A flat fee is payable annually to NBT for its management services.

Distribution and Dealer Compensation

NBII acts as principal distributor for the Fund. In this capacity, NBII buys, sells and swaps securities through Bank branches and the National Bank Investments Advisory Service in Canadian provinces and territories, and through external registered representatives. Fund securities are also offered by National Bank Financial Inc. (including its division National Bank Direct Brokerage), CABN Investments (a division of NBII) and other affiliated entities. Brokers may receive, depending on the distributed series, a monthly commission representing a percentage of the average daily value of the securities held by their clients.

Brokerage Fees

The Fund may pay broker's commissions at market rates to a corporation affiliated with NBII. The brokerage fees paid by the Fund for the period are as follows:

Holdings

As at June 30, 2024, National Bank Investments Inc. held 1,209.63 Fund securities for a value of \$9,673.33, which represented close to 0.0004% of the net asset value of the Fund at that date. Transactions between National Bank Investments Inc. and the Fund were carried out in the normal course of business and at the Fund's net asset value as at the transaction date.

Registered Plan Trust Services

NTC receives a fixed amount per registered account for services provided as trustee for registered plans.

Administrative and Operating Services

The provision of certain services was delegated by the Fund Manager, NBII, to National Bank Trust Inc. ("NBT"), a wholly-owned indirect subsidiary of the Bank. These include accounting, reporting and portfolio valuation services. The fees incurred for these services are paid to NBT by the Fund manager.

Management Fees

The Fund pays annual management fees to the Fund manager for its management services. As the Fund invests in underlying funds, the fees and expenses payable in connection with the management of the underlying funds are in addition to those payable by the Fund. However, the Fund manager makes sure that the Fund does not pay any management (or operating) fees that, to a reasonable person, would duplicate a fee payable by the underlying fund for the same service.

The fees are calculated based on a percentage of the Fund's daily net asset value before applicable taxes and are paid on a monthly basis. Under the *Distribution* heading, expenses include the broker's compensation consisting of the maximum annual trailer fees and sales commissions paid to brokers. Under the *Other* heading, the fees relate mainly to investment management, investment advisory services, general administration and profit. The breakdown of major services provided in consideration of the management fees, expressed as an approximate percentage of the management fees is as follows:

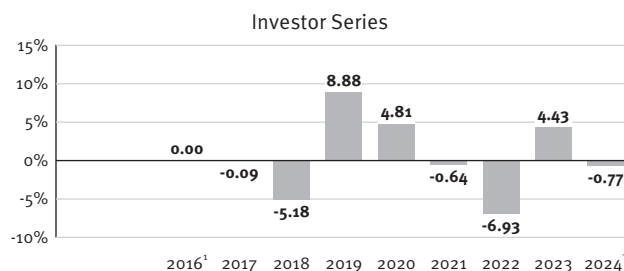
^(***) The Series O is only available to selected investors that have been approved and have entered into an O Series units account agreement with National Bank Investments Inc. The criteria for approval may include the size of the investment, the expected level of account activity and the investor's total investments with NBII. No management fees are charged to the Fund with respect to the O Series units. Management fees are negotiated with and paid directly by investors and are in addition to the fixed-rate administration fee. NBII does not pay any commissions or service fees to dealers who sell O Series units. There are no sales charges payable by investors who purchase O Series units.

Past Performance

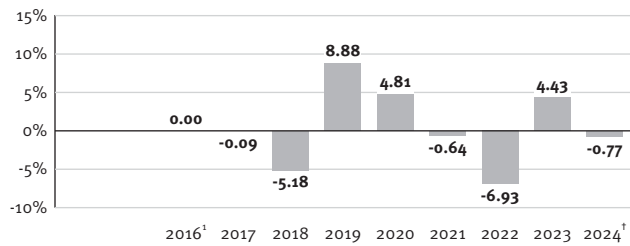

Annual Returns

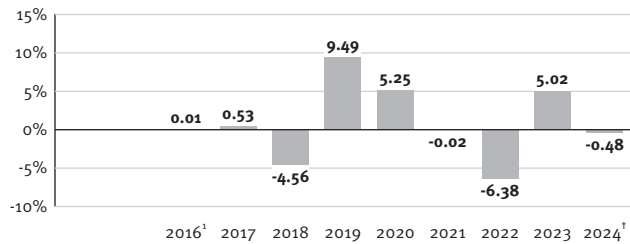

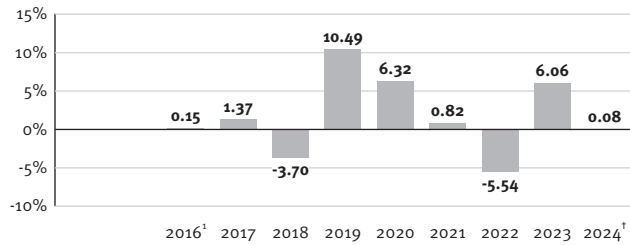

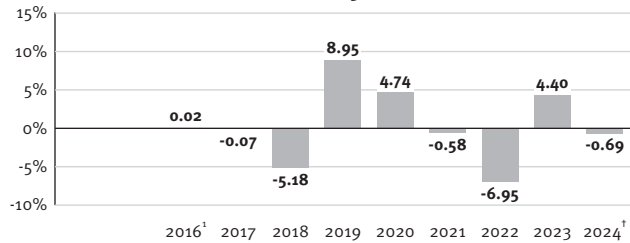
