Management Discussion of Fund Performance

Results of Operations

For the six-month period ended June 30, 2023, the NBI *SmartData* International Equity Fund's Investor Series units returned 8.73% compared to 9.06% for the Fund's benchmark, the MSCI EAFE Index (CAD). Unlike the benchmark, the Fund's performance is calculated after fees and expenses. Please see the *Past Performance* section for the returns of all of the Fund's series, which may vary mainly because of fees and expenses.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the manager. This rate may change from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

The Fund's net asset value dropped by 7.14% over the period, from \$1.416 billion as at December 31, 2022, to \$1.315 billion as at June 30, 2023.

The MSCI EAFE Index rose moderately in the first semester of 2023.

European markets had a strong start to the quarter supported by strong corporate earnings on the back of favourable economic data. However, these gains were capped, and equities remained volatile due to Germany slipping into a technical recession, and the European Central Bank hiking interest rates twice throughout the period.

Japanese equities also had a good quarter buoyed by positive momentum. This was partly fuelled by increased foreign inflow, which was led by the corporate governance reforms and Japan witnessing structural changes in its economy. The Bank of Japan's continuation of the ultra-easy monetary policy contributed to the Yen weakening even further, thus favouring the export oriented Japanese market. For the first time in almost four decades, the country witnessed a period of mild inflation and modest wage growth.

Under these circumstances, the Fund underperformed its benchmark.

Among investment themes, signals within the Sentiment Analysis pillar contributed particularly strongly to relative returns followed by the suite of signals within Fundamental Mispricings. Conversely, signals within the High-Quality Business Models pillar detracted during the period. Signals within Themes and Trends also hurt relative performance.

Within Sentiment Analysis, Analyst & Management Sentiment factors performed well. These factors use natural language processing and machine learning techniques to synthesize sell-side reports and earnings call transcripts to gauge analyst and management sentiment. Meanwhile, signals gauging Industry Rotation within the Fundamental Mispricings pillar helped relative performance meaningfully. On the downside, factors looking at ESG Quality within the High-Quality Business Models pillar hurt relative performance. These factors aim to measure the effect of ESG-related issues such as environmental impact and governance on the firm's future earnings and its reputation. Moreover, within Themes and Trends, signals gauging Price Momentum detracted considerably during the period.

Among sectors, holdings within the Consumer Discretionary sector contributed the most to relative performance, with an overweight position within the Textiles, Apparel & Luxury Goods industry contributing particularly strongly. On the downside, holdings within the Financials sector detracted the most from excess returns, where an underweight position within the Banks industry hurt relative performance.

At an individual stock level, an overweight position in SCREEN Holdings Co Ltd, held primarily due to views around Fundamental Mispricings-related factors, performed well. Conversely, an underweight position in HSBC Holdings PLC, held primarily due to views on Sentiment Analysis-related factors did not do well.

Among countries, the position in France contributed the most to relative performance. Meanwhile, the positioning in the UK detracted during the period.

Recent Developments

There were no material changes in the investment process/strategy during the semester. However, our team has always maintained a robust research effort to develop new factors and data sources in order to maintain innovative sources of alpha.

The Equity Alpha team introduced several new signals and enhancements in the first half of 2023, that leverage machine learning techniques such as Natural Language Processing (NLP) as well as those that are based on different types of alternative data sources.

The team's new NLP-based signals deploy the latest techniques such as large language models and topic modelling to be able to extract insights from different bodies of text.

The first example we would like to highlight are signals we introduced within the Sentiment Analysis investment pillar. This suite of signals seeks to identify changes in sentiment within company regulatory filings and documents by using large language models to synthesize the context of the language used within the document. In addition to the NLP-based signals, the team also introduced a new signal that seeks to capture the level of attention stocks receive as a result of being mentioned in news articles and blog posts. We believe that companies that receive outsized attention in the media experience positive, but temporary price trends that ultimately revert over the longer term. This type of signal was included across most investment regions except for emerging markets.

We also introduced several new signals within the Themes and Trends pillar. The first signal introduced in all regions except Japan, leverages NLP and topic modelling techniques to identify economic linkages between companies based on their current descriptions. The second example we would like to share is the team's suite of signals that leverage word embedding techniques to capture the meanings of the words and language used within employer reviews in order to identify the economic linkages between companies mentioned.

Looking ahead, we continue to believe that cheaper stocks should outpace more expensive ones and good momentum stocks should do better than poor momentum stocks. We also prefer names about which fundamental research analysts are becoming more positive and companies that are profitable, have sustainable earnings and use their capital to enhance shareholder value. As such, we anticipate remaining fully invested and expect that the value we may add over time will be due to stock selection, as opposed to size allocations.

On May 1, 2023, the Fund's independent review committee (the "IRC") was increased to four members when Stéphanie Raymond-Bougie was appointed as an IRC member.

Related Party Transactions

National Bank of Canada ("the Bank") and its affiliated companies' roles and responsibilities related to the Fund are as follows:

Trustee, Custodian, and Registrar

Natcan Trust Company ("NTC"), a direct or indirect wholly-owned subsidiary of the Bank, is the Fund's trustee. In this capacity, it is the legal owner of the Fund's investments.

NTC acts as registrar for the Fund's securities and the names of securityholders. NTC also acts as the Fund's custodian. The fees for NTC's custodial services are based on the standard rates in effect at NTC.

Agent for securities lending transactions

NTC acts as the agent for securities lending transactions acts on behalf of the Fund in administering securities lending transactions entered into by the Fund. NTC is an affiliate of the Manager.

Fund Manager

The Fund is managed by National Bank Investments Inc. ("NBII"), which is a wholly-owned subsidiary of the Bank. Therefore, NBII provides or ensures the provision of all general management and administrative services required by the Fund's current operations, including investment consulting, the arrangement of brokerage contracts for the purchase and sale of the investment portfolio, bookkeeping and other administrative services required by the Fund.

The Manager pays the operating expenses of the Fund other than its "Fund costs" (defined below) (the "variable operating expenses"), in exchange for the Fund's payment to the Manager of annual fixed-rate administration fees with respect to each series of the Fund.

The administration fees are equal to a specified percentage of the net asset value of each series of the Fund, calculated and paid in the same manner as the Fund's management fees. The variable operating expenses payable by the Manager include, but are not limited to: transfer agency and recordkeeping costs; custodial costs; accounting and valuation fees; audit fees and legal fees; costs of preparing and distributing financial reports, simplified prospectuses, annual information forms, Fund Facts, continuous disclosure material and other securityholder communications; and costs of trustee services relating to registered tax plans, as applicable.

In addition to administration fees, the Fund shall also pay certain Fund costs, namely: taxes (including, but not limited to, GST/HST and income taxes); costs of compliance with any changes to existing governmental or regulatory requirements introduced after August 1, 2013; costs of compliance with any new governmental or regulatory requirements, including any new fees introduced after August 1, 2013; interest and borrowing costs; costs related to external services that were not commonly charged in the Canadian mutual fund industry as at August 1, 2013; Independent Review Committee costs, including compensation paid to IRC members, travel expenses, insurance premiums and costs associated with their continuing education; and variable operating expenses incurred outside of the normal course of business of the Fund.

The Manager may, from time to time and at its sole discretion, decide to absorb a portion of a series' management fees, administration fees or Fund costs.

As described under the heading *Management Fees*, the Fund pays annual management fees to NBII as consideration for its services.

Distribution and Dealer Compensation

NBII acts as principal distributor for the Fund. In this capacity, NBII buys, sells and swaps securities through Bank branches and the National Bank Investments Advisory Service in Canadian provinces and territories, and through external registered representatives. Fund securities are also offered by National Bank Financial Inc. (including its division National Bank Direct Brokerage), CABN Investments (a division of NBII) and other affiliated entities. Brokers may receive, depending on the distributed series, a monthly commission representing a percentage of the average daily value of the securities held by their clients.

Brokerage Fees

The Fund may pay broker's commissions at market rates to a corporation affiliated with NBII. The brokerage fees paid by the Fund for the period are as follows:

Holdings

As at June 30, 2023, National Bank Investments Inc. held 17,047.54 Fund securities for a value of \$212,824.64, which represented close to 0.0137% of the net asset value of the Fund at that date. Transactions between National Bank Investments Inc. and the Fund were carried out in the normal course of business and at the Fund's net asset value as at the transaction date.

As at June 30, 2023, National Bank Trust Inc. held 1.28 Fund securities for a value of \$14.31, which represented close to 0.0000% of the net asset value of the Fund at that date. Transactions between National Bank Trust Inc. and the Fund were carried out in the normal course of business and at the Fund's net asset value as at the transaction date.

Registered Plan Trust Services

NTC receives a fixed amount per registered account for services provided as trustee for registered plans.

Administrative and Operating Services

The provision of certain services was delegated by the Fund Manager, NBII, to National Bank Trust Inc. ("NBT"), a wholly-owned indirect subsidiary of the Bank. These include accounting, reporting and portfolio valuation services. The fees incurred for these services are paid to NBT by the Fund manager.

Management Fees

The Fund pays annual management fees to the Fund manager for its management services. The fees are calculated based on a percentage of the Fund's daily net asset value before applicable taxes and are paid on a monthly basis. Under the *Distribution* heading, expenses include the broker's compensation consisting of the maximum annual trailer fees and sales commissions paid to brokers. Under the *Other* heading, the fees relate mainly to investment management, investment advisory services, general administration and profit. The breakdown of major services provided in consideration of the management fees, expressed as an approximate percentage of the management fees is as follows:

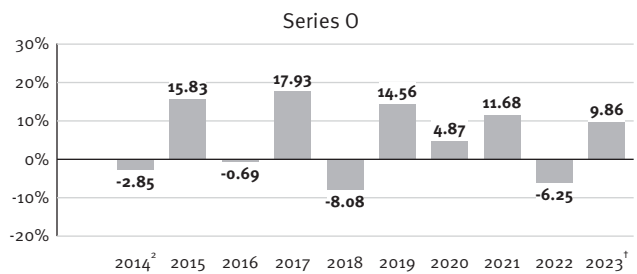

Past Performance

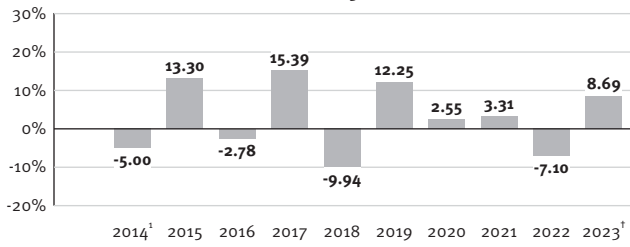
