Management Discussion of Fund Performance

Investment Objective and Strategies

The NBI Quebec Growth Fund's investment objective is to ensure long-term capital growth. The Fund primarily invests in equity securities of corporations whose head office is in Quebec or who do a substantial part of their business in Quebec. It invests in many sectors of the Quebec economy, including communications and media, conglomerates, consumer products, financial services, industrial products, merchandising, metals and minerals, paper and forest products, transportation and environment, and utilities. The Fund provides investors with a way to participate in economic growth in Quebec as part of a diversified portfolio.

The portfolio manager analyzes small, medium and large capitalization companies. When selecting securities in the Fund, the portfolio manager favours security selection over sector rotation and seeks companies with growth potential. It is expected that investments in foreign securities will not exceed approximately 10% of the Fund's assets.

Risks

Results of Operations

For the twelve-month period ended December 31, 2022, the NBI Quebec Growth Fund's Investor Series units returned -6.41% compared to -9.29% for the Fund's benchmark, the S&P/TSX Small Cap Index (CAD). Unlike the benchmark, the Fund's performance is calculated after fees and expenses. Please see the *Past Performance* section for the returns of all of the Fund's series, which may vary mainly because of fees and expenses.

The Fund's net asset value dropped by 1.93% over the period, from \$487.12 million as at December 31, 2021 to \$477.73 million as at December 31, 2022.

Canadian Small Cap stocks rebounded nicely in the fourth quarter but still posted their worst annual drop since the global financial crisis. Some pressures eased in the final months of the year and stocks rallied as inflation started to diminish and central banks eased tightening conditions. Furthermore, China's decision to cease isolation restrictions tied to COVID-19 was beneficial to cyclical stocks like energy and materials. Although investor sentiment has improved recently, no clear direction has been set between pessimism and optimism and the lingering prospects of economic slowdown remains top of mind for many. Except in the final quarter of the year, this difficult market backdrop has generally been worst for small cap stocks as investors have been risk averse since the start of the year. Supply chain issues leading to production delays, labour shortages affecting productivity levels and higher cost structures pressuring profit margins in the context of a potential slowing of demand will be some of the things to watch in our investments during the upcoming year. Mergers and acquisitions will also continue to be topical as better valuations could stimulate consolidation activity.

Over the course of the year, the S&P/TSX Index was down 5.8%; Energy and Consumer staples were the best performing sectors, gaining 30.9% and 10.1% respectively. Real Estate and Utilities were the worst-performing sectors, losing 61.6% and 52.0% respectively throughout

Canadian small caps underperformed their larger peers this year, with the S&P/TSX Small Cap index losing 9.0%. The Energy sector was the only positive contributor to the index's performance, returning 30.5%, while the Communications and Health Care sectors lost 41.4% and 25.8% respectively.

Under these circumstances, the Fund outperformed its benchmark.

• The relative outperformance of the Fund during the period is mainly attributable the positive contribution from our stock selection in the Materials, Communications Services and Financials sectors.

- Our major positive contributors came from Intertape Polymer, Uni Select, Champion Iron, Stella Jones and Dollarama.
- Our major negative contributors came from Tecsys, Nuvei, Heroux Devtek GDI Integrated Facilities and Cargojet.

During the period, we initiated a position in Pet Valu and Sleep Country Canada.

Sleep Country Canada is the leading Canadian mattress and sleep products retailer with a market share near 40%. The company benefits from strong brand awareness, purchasing power and a nationwide reach. With a strong balance sheet, we believe the company is well positioned to continue to grow its presence in its less mature accessories and online markets. Its recently announced partnerships with Wal-Mart and BestBuy will further enhance its leading positioning. At current prices, we believe the stocks offers great value.

Pet Valu is the largest pet food and accessory store in Canada. It has grown to more than 700 corporate and franchised owned stores. It recently announced its entry into the province of Quebec by acquiring Chico, its largest pet specialty franchisor with 66 locations. The company is benefiting from a recent increase is pet ownership. Over the long term, it expects to double its current store base. The industry in resilient and has been growing steadily. We believe that the company can grow and increase profitability for many years to come.

During the period, we sold our positions in Intertape Polymer (takeover offer), Lifeworks (takeover by Telus Corporation), Major Drilling (valuation), NanoXplore (disappointing results) and Superior Plus (disappointing results).

In terms of changes to existing positions, we increased our weighting in Richelieu Hardware, Stella-Jones, Savaria, Gildan Activewear and Heroux Devtek. On the other hand, we decreased our weighting in BRP, Dollarama, Metro, Andlauer Healthcare and Premium Brands.

Recent Developments

- On a sector level, our biggest weightings at the end of the period were in Industrials, Financials, and Consumer Discretionary.
- On a security level, our top holdings at the end of the period were WSP Global, GDI Integrated Facilities, IA Financial, Richelieu Hardware and CGI.

Our current positioning is the result of our bottom-up, long-term investment approach. We are looking to invest in tomorrow's global leaders that have a clear and defined growth strategy. Our investment horizon is long-term if the business plan is evolving in the right direction.

We have limited exposure to commodity sectors (notwithstanding a small exposure to gold) and no exposure to the energy sector. Also, we have minimal exposure to Canadian banks (except for our investment in National Bank of Canada), which differentiates us from most existing Canadian equity funds.

- The growth of the global economy is presently challenged, and recession fears are among us. Pent-up demand exists for many products and services globally as economies reopen but many challenges have arisen that have the potential to slow demand.
- The rise of inflation, increased energy costs, the lack of productivity caused by labour shortages, supply chain disruptions leading to delays and rising interest rates have tempered growth expectations. Although supply chain issues have been resolved in some cases, we continue to closely monitor the availability of certain materials or goods that continue to be impacted by the war in Ukraine.
- As the trajectory of the economy is difficult to predict, we remain focused on investing in companies that have a strong balance sheet and a resilient business model.
- We expect our companies to be active on the acquisition front and further consolidate their marketplace. We also expect some of our investments to become takeover targets as larger companies or private equity funds deploy their excess capital.

• We are optimistic that the companies held in our portfolio will adapt to a somewhat challenging short-term environment and become stronger in their respective markets. Challenges can be surmounted and can even offer opportunities to grow and gain market share versus weaker competitors. Our companies have strong balance sheets and will be able to invest for growth while others won't be able to do so. With their strong balance sheets, they will also be on the lookout for M&A to create value for shareholders.

On April 30, 2022, the Fund's independent review committee (the "IRC") was reduced to three members when Robert Martin resigned as IRC member. On May 1, 2022, the Fund's IRC was increased to four members when Line Deslandes was appointed as IRC member. However, on September 30, 2022, the Fund's IRC was reduced to three members when Line Deslandes resigned as IRC member.

On May 20, 2022, NBI discontinued the purchase offering of deferred sales charge and low sales charge purchase options for all new investments, including purchases made through systematic plans in all Canadian jurisdictions. Investors who purchased units under these sales charge options will continue to be subject to the redemption fee schedules under which they were purchased.

On June 17, 2022, National Bank Trust Inc. replaced Fiera Capital Corporation as portfolio manager of the fund, the latter which became the portfolio sub-advisor.

On or about October 1, 2022, the management fees and maximum annual trailing commissions for the Investor Series and Advisor Series of the Fund were reduced. The management fees were reduced to 1.75% and its maximum annual trailing commissions were reduced to 1.00%.

Related Party Transactions

National Bank of Canada ("the Bank") and its affiliated companies' roles and responsibilities related to the Fund are as follows:

Trustee, Custodian, and Registrar

Natcan Trust Company ("NTC"), a direct or indirect wholly-owned subsidiary of the Bank, is the Fund's trustee. In this capacity, it is the legal owner of the Fund's investments.

NTC acts as registrar for the Fund's securities and the names of securityholders. NTC also acts as the Fund's custodian. The fees for NTC's custodial services are based on the standard rates in effect at

Agent for securities lending transactions

NTC acts as the agent for securities lending transactions acts on behalf of the Fund in administering securities lending transactions entered into by the Fund. NTC is an affiliate of the Manager.

Fund Manager

The Fund is managed by National Bank Investments Inc. ("NBII"), which is a wholly-owned subsidiary of the Bank. Therefore, NBII provides or ensures the provision of all general management and administrative services required by the Fund's current operations, including investment consulting, the arrangement of brokerage contracts for the purchase and sale of the investment portfolio, bookkeeping and other administrative services required by the Fund.

The Manager pays the operating expenses of the Fund other than its "Fund costs" (defined below) (the "variable operating expenses"), in exchange for the Fund's payment to the Manager of annual fixed-rate administration fees with respect to each series of the Fund.

The administration fees are equal to a specified percentage of the net asset value of each series of the Fund, calculated and paid in the same manner as the Fund's management fees. The variable operating expenses payable by the Manager include, but are not limited to: transfer agency and recordkeeping costs; custodial costs; accounting and valuation fees; audit fees and legal fees; costs of preparing and distributing financial reports, simplified prospectuses, annual information forms, Fund Facts, continuous disclosure material and other securityholder communications; and costs of trustee services relating to registered tax plans, as applicable.

In addition to administration fees, the Fund shall also pay certain Fund costs, namely: taxes (including, but not limited to, GST/HST and income taxes); costs of compliance with any changes to existing governmental or regulatory requirements introduced after August 1, 2013; costs of compliance with any new governmental or regulatory requirements, including any new fees introduced after August 1, 2013; interest and borrowing costs; costs related to external services that were not commonly charged in the Canadian mutual fund industry as at August 1, 2013; Independent Review Committee costs, including compensation paid to IRC members, travel expenses, insurance premiums and costs associated with their continuing education; and variable operating expenses incurred outside of the normal course of business of the Fund.

The Manager may, from time to time and at its sole discretion, decide to absorb a portion of a series' management fees, administration fees or Fund costs.

As described under the heading *Management Fees*, the Fund pays annual management fees to NBII as consideration for its services.

Portfolio Manager

The Manager has appointed National Bank Trust Inc. ("NBT"), an indirect wholly-owned subsidiary of the Bank, as the portfolio manager for the Fund. A flat fee is payable annually to NBT for its management services.

Distribution and Dealer Compensation

NBII acts as principal distributor for the Fund. In this capacity, NBII buys, sells and swaps securities through Bank branches and the National Bank Investments Advisory Service in Canadian provinces and territories, and through external registered representatives. Fund securities are also offered by National Bank Financial Inc. (including its division National Bank Direct Brokerage), CABN Investments (a division of NBII) and other affiliated entities. Brokers may receive, depending on the distributed series, a monthly commission representing a percentage of the average daily value of the securities held by their clients.

Brokerage Fees

The Fund may pay broker's commissions at market rates to a corporation affiliated with NBII. The brokerage fees paid by the Fund for the period are as follows:

Independent Review Committee Approvals and Recommendations

The Fund followed the standing instructions of its Independent Review Committee with respect to one or more of the following transactions:

- a) Purchasing or holding the securities of a related issuer, in particular, those of National Bank of Canada;
- Investing in the securities of an issuer when an entity related to the manager acts as an underwriter for the placement or at any time during the 6o-day period after the end of the placement;
- Purchasing or selling securities to another investment Fund managed by the manager or a company in the same group;
- d) Purchasing or selling debt securities on the secondary market, through related brokers that are main brokers in the Canadian debt securities market (in accordance with an exemption received from the Canadian Securities Administrators):
- Entering into foreign exchange transactions (including both spot transactions and forward transactions) with National Bank of Canada.

The Manager has implemented policies and procedures to make sure that the conditions applicable to each of the above transactions are met. The applicable standing instructions require that these transactions be carried out in accordance with NBII policies, which specify, in particular, that investment decisions pertaining to these related party transactions must be made free from any influence by an entity related to NBII and without taking into account any consideration relevant to an entity related to NBII. Furthermore, the investment decisions must represent the business judgment of the securities advisor, uninfluenced by considerations other than the best interest of the Fund and must achieve a fair and reasonable result for the Fund.

Registered Plan Trust Services

NTC receives a fixed amount per registered account for services provided as trustee for registered plans.

Administrative and Operating Services

The provision of certain services was delegated by the Fund Manager, NBII, to National Bank Trust Inc. ("NBT"), a wholly-owned indirect subsidiary of the Bank. These include accounting, reporting and portfolio valuation services. The fees incurred for these services are paid to NBT by the Fund manager.

Management Fees

The Fund pays annual management fees to the Fund manager for its management services. The fees are calculated based on a percentage of the Fund's daily net asset value before applicable taxes and are paid on a monthly basis. Under the *Distribution* heading, expenses include the broker's compensation consisting of the maximum annual trailer fees and sales commissions paid to brokers. Under the *Other* heading, the fees relate mainly to investment management, investment advisory services, general administration and profit. The breakdown of major services provided in consideration of the management fees, expressed as an approximate percentage of the management fees is as follows:

Past Performance

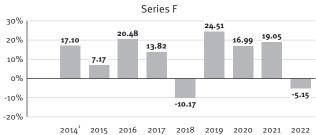
